- Raised \$33 million for Cape Lambert Iron Ore Ltd (now Cape Lambert Resources Ltd).
- Listed Cape Lambert on London Stock Exchange (AIM).
- Listed Global Iron Limited on the ASX in August 2007
- Sold an iron ore mine in WA to MCC for \$400m after paying \$10m cash for it.
- Listed International Goldfields Limited on the ASX in May 2006.
- Purchased CopperCo group assets in June 2009.
- In 2009 Cape Lambert win AIM company of the year and Tony Sage is voted Mining Executive of the Year (Australia).
- Floated African Iron Ltd on ASX then sold the iron ore asset in Congo to Exxaro for a see-through value of \$420m.
- Assisted in the funding for the iron industry in Sierra Leone (\$2b).
- Sold the Lady Loretta zinc mine for \$35m.
- Sold Lady Annie copper mine for \$135m.
- Floated Glory Resources Ltd on the ASX and raised \$42m for the Sappes Gold Mine in Greece.
- Floated European Lithium Ltd at \$8m (18 months ago) current market cap \$130m.
- Purchased Cobalt assets in DRC for the future.
